





INSTALLING H744A-8 PULLING HEAD ON RIVETER



- 1. Insert spring (J) into head piston (6).
- 2. Place jaws (F) inside collet (E). Place O-ring (I) over jaw follower (H) and put this assembly inside collet against jaws. Screw this assembly onto end of head piston (6). Tighten securely, using wrenches on flats provided.
- 3. Thread outer sleeve (C), which contains jam nut (D), snugly into end of head cylinder (1). Tighten jam nut (D).
- 4. In case of damage to the pulling head, dismantle and replace with parts selected from list below.
