

CHOICE OF RIVETERS

- **G84** Power Riveter (no adapter necessary)
- **G84-LS** Split Power Riveter (with adaptor 744-700)

MOUNTING INSTRUCTIONS (ON G83/G84 riveters)

- 1. Remove the Bayonet Adapter (700-211) from the Riveter and replace with Adapter item 10
- 2. Assemble Collet with all internal components onto the Riveter Piston
- 3. Thread the Sleeve (Item 1) onto the adapter. (Item 10) and tighten with the Jam Nut (item9); use Loctite 242 on all threads (except Riveter Piston) to secure the threaded component.

USAGE

• This tool is designed to install 5, 6 and 8 diameter Maxibolt® Plus blind bolts.

BEFORE USE, MAKE SURE THAT:

- The correct pulling head and nose piece are used and that they are properly mounted on the recommended riveter.
- Proper air source is connected (see riveter specification for recommended pressure).
- Make sure that the tool is clean and in good working condition

DURING OPERATION

- Inspect the active area of the nose piece regularly.
- Keep the nose piece and jaws clean especially when sealants are used.
- If stem slippage occurs, the jaws need to be either cleaned or replaced.

INSTRUCTIONS

- 1. Item 11 (Alternate Jaw Follower) is purchased separately and is intended to replace the standard Jaw Follower (item 4) when installing -5 and -6 size MaxiBolt Plus products to prevent stem shingling.
 - Caution: This component will not accept -8 diameter MaxiBolts.
- 2. Make certain the pulling head is kept clean, especially around the riveting end, as adhesives, chips, sealants, etc., will clog up the serrations of the jaws and may cause slippage of the stem.
- 3. In case of damage to the pulling head, dismantle and replace with parts selected from the list above.

PREVENTATIVE MAINTENANCE

Clean the collet and jaws every 1,000 installations. Lubricate the conical surface of the jaws before reassembly. Check the internal components (especially springs) for wear; replace when necessary.
