

#### **CHOICE OF RIVETERS**

This die will work with either automatic riveting machines or a pneumatic squeezer; use 839B3 (3/16 mount) and 839B13 (1/4" mount)


#### OPERATING INSTRUCTIONS

#### Before operating the tool, make sure that:

- The die is clean and in good working condition; if the flaring portion of the die is damaged, replace.
- Proper Air source is connected (see Squeezer manual for air pressure).


## PREVENTATIVE MAINTENANCE

. Inspect the flaring area of the die for signs of wear and galling; re-polish if it is dirty or galled up.
